Zimmer Biomet Fellowship Funding Request Process (Canada Only)


Requests are initiated by submitting a written request through the online Grants Portal. Zimmer Biomet utilizes the platform “MediSpend” as our Grants Portal. For best outcome, utilize Google Chrome as your Search Engine.

NOTE: Once you submit a request, you will receive a supplemental application form to obtain additional information about the fellowship program. The supplemental application should be completed and returned as quickly as possible, but no later than 2 weeks past the application period deadline.

Please refer to the end of this user guide for specific requirements of a completed application. An application will not be considered until requirements are complete.

- You only need to register once. If you already have an account, you can skip this step.
- Type in First Name, Last Name, and Email
- Click Register
- An auto-generated email will be sent with a temporary password to the email address used to register



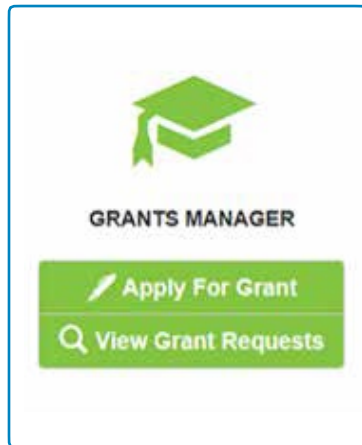

- **Program/Event Description:** Description of Fellowship Program
- **Program/Event Venue:** University and Hospital(s) associated with Fellowship Program

 - If approved, funding for Spine and CMF/Thoracic fellowship programs will be awarded in the range of \$25,000 - \$50,000 CAD based on the demonstrated need of the program. Funding for all other orthopaedic subspecialty fellowship programs will be awarded in the amount of \$50,000 CAD or the demonstrated need of the program, whichever is lower. All grant funding decisions are at the discretion of the Zimmer Biomet Corporate Grants Committee. Due to the substantial amount of each grant award, the number of grants awarded will be limited. Therefore, it is possible that not all applicants will receive funding.

Applying for a Grant *(continued)*

The next tab is **Requestor Info**.

This information **MUST** be the Legal Entity's Name and Address. For example, you would enter the same information found on Government Documentation or what is on your W8. This entity will be the organization with which the agreement and payment will be made if the application is approved.

NOTE: Zimmer Biomet will not make agreements with or pay any individuals, medical practices, or private healthcare institutions. Entity must be a public hospital, university/academic institution, or an associated foundation. Payment will only be made via international wire transfer. Please be aware of these requirements when entering your information.

- **Legal Entity Name:** As referenced above, must be the organization the agreement and payment will be with (Must be a public hospital, university/academic institution, or an associated foundation)
- **Country:** Canada
- **Region:** Province in which entity is located
- **Address:** Legal address of the entity named above (should match the W8 tax form)
- **City:** City in which the entity is located
- **Zip code:** Zip code of the entity
- **Contact First Name:** First name of the fellowship Program Director
- **Contact Last Name:** Last name of the fellowship Program Director
- **Requestor Title:** Program Director, as well as any other titles held
- **Phone Number:** Phone number of the fellowship Program Director
- **Email Address:** Email address of the fellowship Program Director

The **Attachments** tab is next.

After the details of the grant have been entered into the system, you will need to attach supporting documentation. By clicking on the drop down list you will find what is required by the asterisk (*).

You can choose multiple selections at a time or just one depending on how your documentation is structured. If you choose to upload documents individually, you will need to unselect the previous box before choosing a new one or the attachment will receive multiple names.

The uploaded document and information will appear on the screen once upload is complete.

Below is a description of what Zimmer Biomet is looking for when requesting supporting documentation.

- **Request Letter on Organization’s Letterhead:** A description of the purpose for the grant/fellowship support
- **Program Agenda/Brochure/Objectives:** Breakdown of the fellowship curriculum, guidelines, and objectives as required by the program, as well as any marketing collateral of the program
- **Accreditation Documentation (if applicable):** Certification of active membership with an accrediting institution
- **Mission Statement and Board of Directors/Executive Officers or Bylaws:** Organization’s official mission and list of Board of Directors/Executive Officers for the legal entity’s organization
- **Program budget including anticipated income and expenses:** the total amount of funding requested and a budget that sets forth how the funding will be used. *Reminder, fellowship funding is intended to support fellow’s salary and benefits only*
- **W8:** Identifying information about the prospective legal entity. This must match the information supplied in the Requestor Info tab. You must submit a form with your application, but you will be required to submit this again through an online tax portal provided later in the process if funding is approved.

Applying for a Grant *(continued)*

Submitting the Request

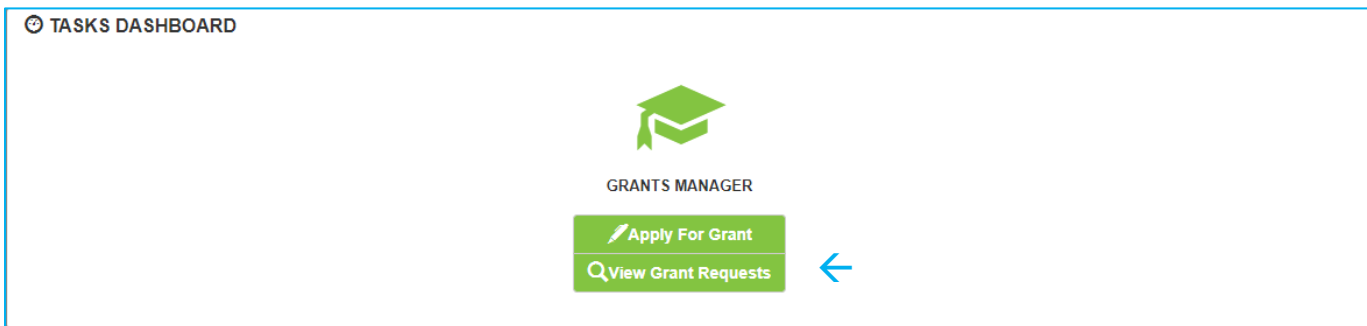
Once all of the information and attached supporting documentation is uploaded, it is time to submit the request.



If you are still working on the request, you can click Save Draft and come back to the request later.

Once the Submit Grant button request is clicked, you should receive a confirmation email. If you do not receive a confirmation email, please reach out to Grants.AMER@zimmerbiomet.com to confirm there were no issues with receipt of the application.

You can check on the status of the request by clicking on the “View Grant Request” button located on the Tasks Dashboard.



Completion and Notification

Zimmer Biomet will communicate with the requester to obtain any additional information needed to evaluate the request and provide the supplemental application. Your application will be considered complete upon submission of the following to Zimmer Biomet:

- Completed and Submitted Medispend grant application by the close of the application period
- Completed Supplemental Application no later than 2 weeks past the application period deadline
- An approved entity with appropriate W8 form

NOTE: If Zimmer Biomet does not have a submitted online application, an approved entity with a W8, and the completed supplemental application within 2 weeks of the application period deadline, your application will be deemed late and will not be considered for review.

Once complete, the application will route the request to the Zimmer Biomet Fellowship Review Committee. The organization will receive written notification once the committee has reviewed and made a decision. If a grant is approved, you will be notified and sent a written agreement.
